(a) & (b) The mandate of the Department of Social Justice and Empowerment (DoSJE) is to take care of the welfare of the poorest households of the socially, educationally and economically marginalized sections of the society including Scheduled Castes (SCs), Other Backward Classes, Senior Citizens, Victims of Alcoholism and Substance Abuse, Sanitation Workers, Transgender Persons, Beggars, De-notified and Nomadic Tribes (DNTs), Economically Backward Classes (EBCs), Economically Weaker Section (EWS). This Department is implementing several Schemes for their welfare across India including Assam. The details of the major schemes along with funds allocated and fund released in last five years to all States/UTs including Assam is given in Annexure.
