ARCHIVAL RECORDS MAINTAINED BY NAI

646. DR. C.M. RAMESH:

Will the Minister of CULTURE be pleased to state:

- (a) whether the records of National Archives of India (NAI), which maintains archival records including records of various Government Departments, are updated and digitized, details thereof; and
- (b) whether some posts in NAI are lying vacant, if so, date from which these posts are lying vacant and steps taken by Government to fill up those posts, details thereof and if not, the reasons therefor?

ANSWER

MINISTER OF CULTURE, TOURISM AND DEVELOPMENT OF NORTH EASTERN REGION (SHRI G. KISHAN REDDY)

(a) National Archives of India initiated a project for digitization of its records in January 2021. In the first phase a large scale digitization has been initiated by National Achieves of India through an outsourcing agency for a period of three years. As on 02.02.2024, 3.83 Crore pages have been digitized for uploading on the search portal https://www.abhilekh-patal.in for their accessibility to Scholars, Historians, Academicians, Researchers and other users of archives in the country as well as across the world.

Further, in the second phase, NAI has initiated a project of digitization of all its records holding through outsourcing agency.

(b) Yes. Some posts in NAI are lying vacant. The relevant proposals for filling up of these vacant posts have been submitted to SSC/UPSC as the case may be. Steps taken by Government to fill up these vacant posts have been detailed as Annexure.
