(c) steps taken by Government to utilize Artificial Intelligence for grain analysis?

(a): The State/Union Territory-wise allocation details of the foodgrains (rice & wheat) during the last three years and current year is at **Annexure-I**.

(b): Rs. 250.28 Cr. has been released to the State Government of Punjab since 2017-18 onwards under the scheme "Assistance to State Agencies for intra-State movement of foodgrains and FPS dealers' margin".

(c): FCI introduced Artificial Intelligence based Automatic Grain Analyzers in the field of Quality Assessment and procurement of foodgrains. Utilizing Artificial Intelligence (AI) for foodgrains analysis helps in removing human intervention and also brings transparency in the procurement system. During Phase-I, 50 AI based Automated Grain Analyzers were installed at the rice procuring centers and recently 350 AI based Automated Grains Analyzers were installed at major procuring centers in 10 States of the country. Quality check during procurement of food grains is being done by these AI based Automated Grain Analyzers.
