Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) the details of foodgrains procured by Government from each State and the price paid to the farmers for each item during the last one year;
- (b) whether Food Corporation of India (FCI) has sufficient storage capacity to store the foodgrains procured every year;
- (c) if so, the details thereof, State-wise;
- (d) if not, the reasons therefor; and
- (e) the steps being taken to increase the storage capacity in each State, particularly in the States where there is maximum production of crops?

(a): State-wise quantity of Paddy and Wheat procured by Government agencies for Central Pool and MSP value paid to farmers during last one year is at **Annexure-I & Annexure-II** respectively.

Details of Coarse grains procured and MSP paid during the last one year is at **Annexure-III**.

Details of Pulses procured at MSP under Price Support Scheme (PSS) and Price Stabilization Fund (PSF) and MSP value paid during the last one year are at **Annexure-IV & Annexure-V** respectively.

(b) to (d): Yes, Sir. As on 01.01.2024, Covered Storage Capacity available with FCI and State agencies for storage of Central Pool foodgrain stock is 762.36 Lakh MT against stored stock of 341.01 Lakh MT. The State-wise details are at **Annexure-VI**.

(e): The requirement of Storage capacity in FCI depends upon the level of procurement, requirement of buffer norms and PDS operations for Rice and Wheat mainly. FCI continuously assesses and monitors the storage capacity and based on the storage gap assessment, storage capacities are created/hired through following schemes:-

1. Private Entrepreneurs Guarantee (PEG) Scheme
2. Central Sector Scheme "Storage & Godowns"
3. Construction of SILO's under PPP mode
4. Hiring of godown from Central Warehousing Corporation (CWC)/State Warehousing Corporations (SWCs)/State Agencies
5. Hiring of godown through Private Warehousing Scheme (PWS)
6. Creation of godowns under Asset Monetization.
