#### AREA UNDER ORGANIC FARMING

#### 806. SHRI TIRUCHI SIVA:

Will the Minister of AGRICULTURE & FARMERS WELFARE be pleased to state:

- (a) the detailed break-up of the area under organic farming in the country, State-wise;
- (b) the achievements of Paramparagat Krishi Vikas Yojana (PKVY) since its inception in 2019, the details thereof, State-wise; and
- (c) the details of the clusters formed under PKVY till date, in the State of Tamil Nadu?

#### **ANSWER**

#### MINISTER OF AGRICULTURE AND FARMERS WELFARE

- (a): The State-wise detailed break-up of the area under organic farming (National Programme for Organic Production (NPOP) + Participatory Guarantee System (PGS)- India certification) since 2015-16 is at **Annexure-I.**
- (b) & (c): Government of India has been promoting Organic farming in the country through dedicated scheme namely Paramparagat Krishi Vikas Yojana (PKVY) since 2015-16. The scheme provides end to end support to organic farmers i.e. from production to certification and marketing. Trainings and capacity buildings as well as post harvest management support including processing, packing and marketing are made integral part of the scheme to encourage organic farmers.

Since 2015-16, under PKVY, 14.13 lakh ha area has been covered under organic farming by developing 46925 clusters involving 16.19 lakh farmers. In addition, 8 states developed their own brands for organic products.
