#### 3. Sugar Subsidy Scheme

The Central Government has decontrolled the sugar sector by removing the levy obligation on sugar mills from 2012-13 sugar seasons. The new dispensation for distribution of sugar under PDS was put in place after de-regulation of sugar sector by way of introducing 'Sugar Subsidy Scheme'. The coverage of the sugar subsidy scheme introduced with effect from June, 2013, after de-regulation of sugar sector, targeted Below Poverty Line (BPL) population (inclusive of poorest of poor person in the country i.e. Antyodaya Anna Yojana (AAY) families) and all the population of North Eastern States/ Special Category States/ Hilly States and Island Territories. The Central Government is reimbursing a fixed subsidy of Rs. 18.50 per kg @ 1 Kg per month per AAY families to participating States/UTs. Kerala and Maharashtra are participating in this scheme however, Assam is not participating under the said scheme. The details of funds released to Kerala & Maharashtra are as under:

## 3. (A) Scheme/project of Strengthening of Price Monitoring Cell – Operational since October, 2014

The Department of Consumer Affairs (DoCA) monitors the daily retail and wholesale price of identified essential food items through daily retail and wholesale prices reported by the Price Reporting Centers under the Consumer Affairs, Food & Civil Supply Department in the States and UTs. Financial assistance in the form of grant-in-aid is provided to the States/UTs for the Price Reporting Centers under the scheme – Strengthening of Price Monitoring Cell.

#### 3 (B). Price Stabilization Fund (PSF)

#### **3.1 PSF**

The Price Stabilization Fund (PSF) was set up in 2014-15 with an initial corpus of ₹500 crore to tackle inflationary trends of some agri-horticultural commodities viz. onion, potatoes and pulses to protect the interests of consumers. These commodities would be procured and stored for regulated release to help moderate the prices. Such market intervention by Government would not only help send the appropriate market signal but also deter speculative/hoarding activities. To begin with, the Fund was to be used only for market interventions in case of perishable agri-horticultural commodities such as onion and potato which showed extreme volatility of prices. Subsequently, pulses were also covered. As per the scheme, the PSF is to be used to grant interest free advance of working capital to Central Agencies, State/UT Governments/Agencies to undertake such market intervention operations. Apart from domestic procurement from farmers/wholesale mandis, imports may also be undertaken under PSF for building adequate buffer at reasonable cost. Interest free advances from the PSF corpus may be made both to Central Agencies and to State level Corpus. The State level Corpus is created with a sharing pattern between Government of India and States in the ratio of 50: 50, which is 75:25 in case the North Eastern States. In the States/UTs, the price stabilization operations are to be managed by the State level PSFMC and operated out of the State level Corpus Fund.
