- (a) the total number of national highway projects sanctioned in the State of Telangana during last three years;
- (b) the pending and delayed National Highway Projects with expected completion date in the State of Telangana, details thereof; and
- (c) the original cost and expected increase in cost of these projects due to delay in project completion, details thereof?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) IN RESPECT OF RAJYA SABHA STARRED QUESTION NO. 103 FOR REPLY ON 31.07.2024 REGARDING NATIONAL HIGHWAY PROJECTS IN TELANGANA ASKED BY SHRI ANIL KUMAR YADAV MANDADI.

- (a): Total 51 National Highway projects have been sanctioned in the State of Telangana during the last three years.
- (b) Details of 13 projects awarded but Appointed Date not declared are at Annexure-A. Scheduled Completion date of 24 ongoing projects have been revised for various reasons. Details of such projects are at Annexure-B.
- (c) Total original cost of 24 projects, where Scheduled Completion date has been revised, is Rs. 5,370 crore. Additional financial implication is not incurred in all delayed projects. If delay is not attributable to the Contractor, price adjustment is paid as per contract conditions, which may or may not result in additional cost, depending upon final value of price adjustment determined on actual completion of project and final settlement of bills. If delay is attributable to the Contractor, damages are imposed and there is no additional cost due to delay.
