**Impact of closure of coal mines**

†\*145. Smt. Priyanka Chaturvedi:

Will the Minister of **COAL** be pleased to state:

- (a) the details of coal mines shut down and proposed to be shut down, State-wise, between 2021 to 2025;
- (b) the number of people affected by the closure of these mines, State-wise, in terms of employment loss, with separate details of its impact on male, female and Scheduled Caste or Scheduled Tribe workers;
- (c) whether any alternate employment, compensation, or financial aid is being provided to those whose livelihood is affected by the closure of coal mines; and
- (d) if so, the details thereof and if not, the reasons therefor?

**STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF THE RAJYA SABHA STARRED QUESTION NO. 145 ANSWERED ON 05.08.2024 ASKED BY SMT. PRIYANKA CHATURVEDI, HON'BLE MP REGARDING 'IMPACT OF CLOSURE OF COAL MINES'.**

(a): There are three coal companies under Ministry of Coal, namely Coal India Limited (CIL), Neyveli Lignite Corporation India Limited (NLCIL) and Singareni Collieries Company Limited (SCCL). No mine has been shut down (closed) in Coal India Limited (CIL) from 2021 to till date as per the mine closure guidelines issued by Ministry of Coal. Further, the following mines of CIL have been proposed to be closed by 2025 as per the mine closure guidelines -

Such employees posted in a mine at the time of its closure are transferred to other mines/ areas/ subsidiaries as per requirement for their gainful utilization. As such, the livelihood of the employees of coal mines is not affected due to closure of any mine.
