Will the Minister of **Fisheries, Animal Husbandry and Dairying** be pleased to state:

- (a) the role of the Rashtriya Gokul Mission (RGM) in amplifying milk production, enhancing the productivity of indigenous bovine breeds;
- (b) the progress made during last three years, State-wise; and
- (c) whether the Rashtriya Gokul Mission has increased financial stability for rural farmers engaged in dairying throughout the country?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF THE RAJYA SABHA STARRED QUESTION NO. *173 RASHTRIYA GOKUL MISSION (RGM) TO BE ANSWERED ON 07th AUGUST 2024.

(a) to (c) To enhance milk production and productivity of indigenous bovine breeds, Department of Animal Husbandry and Dairying is implementing Rashtriya Gokul Mission since December 2014 for development and conservation of indigenous breeds, genetic upgradation of bovine population thereby making milk production more remunerative to farmers. The scheme is leading to multiplication of elite animals of indigenous breeds and increased availability of indigenous stock. The scheme is continued under revised and realigned schemes of the Department from 2021-22 to 2025-26.

Following efforts are made by the Department of Animal Husbandry and Dairying for enhancing productivity of bovines and milk production in the country (i) Implementation of Nationwide Artificial Insemination Programme for extending artificial insemination coverage and increasing milk production and productivity of bovines including indigenous breeds; (ii) Induction of MAITRIs (Multi-purpose Artificial Insemination Technicians in Rural India) for delivery of artificial insemination services at farmers doorstep; (iii) implementation of progeny testing and pedigree selection for production of high genetic merit bulls including bulls of indigenous breeds; (iv) accelerated breed improvement programme using sex sorted semen of high genetic merit bulls including indigenous breeds; (v) accelerated breed improvement programme using IVF technology for propagation of elite animals of indigenous breeds and (vi) establishment of breed multiplication farms preferably of indigenous breeds.

Due to implementation of Rashtriya Gokul Mission and other measures taken by Government of India, milk production has increased by 57.62% over the past 9 years from 146.3 million tonnes during 2014-15 to 230.60 million metric tonnes during 2022-23. Milk production is growing at the annual growth rate of 5.9 % over the past 9 years. During last 9 years average productivity of cattle and buffaloes milk is increased by 27% from 1648.17 kg per animal per year during 2013-14 to 2079 kg per animal per year in 2022-23 which is highest productivity growth rate in the world.

As per the estimates of National Account Statistics (NAS) 2024, the value of output of milk is more than Rs.11.16 lakh crore which is the highest of the agriculture produce and even more than the combined value of Paddy and Wheat. The benefit of the scheme is accruing to more than 9 crore dairy farmers.
