BENEFICIARIES UNDER PM KISAN IN PUNJAB

*49. SHRI VIKRAMJIT SINGH SAHNEY:

Will the Minister of Agriculture and Farmers Welfare be pleased to state:

(a) the number of beneficiaries who received instalments of Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) during the last three years in Punjab, instalment-wise, State-wise and district-wise;

(b) whether it is a fact that the number of beneficiaries in Punjab under the said scheme have dropped by 45 per cent in the Financial Year 2022-23 to 2023-24;

(c) if so, the reasons therefor;

(d) whether Government is planning to launch a registration campaign for this scheme so that assistance could be provided to those whose names are taken out from the beneficiary list; and

(e) if so, the details thereof, if not, the reasons therefor?

ANSWER

(a) to (e): A statement is laid on the table of the House.

STATEMENT MADE IN REPLY OF PARTS (a) to (e) OF RAJYA SABHA STARRED QUESTION NO. 49 RAISED BY SHRI VIKRAMJIT SINGH SAHNEY, MP DUE FOR REPLY ON 26/07/2024.

(a) to (e): The PM-KISAN scheme is a central sector scheme launched in February 2019 by the Hon'ble Prime Minister to supplement the financial needs of land-holding farmers. Under the scheme, a financial benefit of Rs 6,000/- per year is transferred in three equal instalments, into the Aadhaar seeded bank accounts of farmers through Direct Benefit Transfer (DBT) mode. The PM-KISAN scheme is the largest DBT Scheme of the World.

A farmer-centric digital infrastructure has ensured the benefits of the scheme reach all the farmers across the country without involvement of any middlemen. Maintaining absolute transparency in registering and verifying beneficiaries, the Government of India has disbursed over Rs 3.24 lakh Cr to more than 11 Cr farmers in 17 instalments since inception. The number of beneficiaries who received benefits under the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) during the last three years in the Punjab, instalment-wise and district-wise is attached at Annexure.

As per operational guidelines of the Scheme, States/UTs are mandated to identify and verify the eligible beneficiaries under the scheme and upload the details of eligible farmers including land records, linking of Aadhaar with their bank accounts and e-KYC for successful transfer of the benefits. Benefits of the scheme are transferred to the beneficiaries through Direct Benefit Transfer (DBT) mode, based on the verified data received from the States/UTs on the PM-KISAN portal.

To ensure that the benefits are provided only to the intended beneficiaries, e-KYC, land seeding, and Aadhaar-based payment have been made mandatory under the scheme. Land seeding was made mandatory during the release of the 12th installment of the scheme (August 2022 - November 2022), and Aadhaar-based payment was made mandatory from the 13th installment (December 2022 - March 2023) onwards. e-KYC was made mandatory from the 15th installment (April 2023 - July 2023). In this process, the total numbers of beneficiaries benefitted in the scheme in the 12th Installment period were decreased across the states including the Punjab. This decrease was nominal in the States who proactively undertook suitable measures and completed the above said mandatory requirements. However, in the case of Punjab, in 2022-23 during the 12th installment period, they could complete the land seeding for only 2.07 lakh farmers, and

accordingly, the benefits were released to them. In 2023-24, during the 16th installment (December 2023 – March 2024), the benefits was released to about 7.2 lakh farmers whose land seeding, Aadhaar-based payments, and e-KYC were completed.

The Ministry often undertakes saturation drives in coordination with the State Governments to ensure that no eligible farmers are left out from the Scheme. The recent nationwide saturation drive was undertaken from 15 November 2023, under the Viksit Bharat Sankalp Yatra (VBSY), to saturate the scheme with all eligible farmers. More than 1.0 cr farmers were covered during the VBSY campaign across the country, out of which over 2.20 lakh farmers were from the Punjab.

Further, Village Level Nodal officers were designated to onboard all the eligible farmers under the PM-KISAN scheme from villages assigned to them and to complete the mandatory requirements of the farmers to receive the benefits of the scheme. Further services of the PM-KISAN scheme have also been made available over 5.0 lakh Common Services Centers across the country to enable the farmers to avail the services at their doorstep and complete their mandatory requirement if any to receive the uninterrupted benefits of the PM-KISAN Scheme.

The validation checks of land seeding, Aadhaar linking with bank accounts, eKYC and payment to the eligible beneficiaries are ongoing processes. As and when the farmers complete the mandatory requirements, they receive benefits of all outstanding instalments. Hence, there is no loss to the beneficiaries.
