**FUNDS ALLOCATED TO STATE PRISONS**

**Will the Minister of HOME AFFAIRS be pleased to state:**

- (a) the amount of funds allocated by Government to state prison authorities during the last five years, State-wise;**
- (b) the details of capacity of jails to hold inmates and their present number of inmates in various jails, state-wise; and**
- (c) whether Government has considered increasing budget allocation towards prison authorities to expand prison capacity in light of overcrowding of prisons and if so, details thereof?**

**(a): State/Union Territory (UT)-wise details of funds released by the Ministry of Home Affairs to the State Prison Authorities during the last five financial years are given in Annexure-I.**

**(b): The National Crime Records Bureau (NCRB) compiles prison statistics reported to it by the States and Union Territories and publishes the same in its annual publication “Prison Statistics India”. The latest published report is of the year 2022. State/UT-wise details of capacity of prisons and inmate population as on 31<sup>st</sup> December, 2022 are given in Annexure-II.**

**(c): ‘Prisons’/‘persons detained therein’ is a “State List” subject under List II of the Seventh Schedule to the Constitution of India. The administration and management of prisons and prisoners is, therefore, the responsibility of respective State Governments, who are competent to make adequate budgetary provisions in their respective jurisdictions, as per local need and requirements. The Central Government, on its part, has been supporting the States and UTs in strengthening technological interventions and in upgrading security infrastructure etc. in Prisons and Correctional Institutions.**
