Will the Minister of Social Justice and Empowerment be pleased to state:

- (a) the details of pension schemes under the National Social Assistance Programme, along with the eligibility criteria;
- (b) the total number of eligible beneficiaries and total individuals currently covered under the various scheme, State-wise;
- (c) the year-wise outlay and expenditure of Union Budget under various pension schemes, since 2019; and
- (d) the measures taken to reduce the delay in payments of the pension?

ANSWER

THE MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT

(SHRI B.L.VERMA)

- (a) National Social Assistance Programme (NSAP) is implemented across the country as a social security programme, primarily meant for vulnerable sections of the society such as old aged, widows, and disabled persons belonging to Below Poverty Line (BPL) by Ministry of Rural Development. Details and eligibility criteria of three pension schemes under NSAP is given at Annexure-I.
- (b) Allocation of funds under NSAP schemes to States/UTs is done on the basis of ceiling of beneficiaries (State cap) or the number of beneficiaries digitized on the NSAP portal, whichever is lower. State-wise total number of beneficiaries covered under the schemes of NSAP is given at Annexure-II.
- (c) Year-wise outlay and expenditure of pension schemes under NSAP since Year 2019 is given at Annexure-III.
- (d) Measures such as digitization of beneficiary data, Direct Benefit Transfer (DBT), Aadhaar Seeding, Mobile Seeding, Aadhaar Payment Bridge etc. have been adopted under NSAP for speedy disbursement of pension and effective implementation.

Details and eligibility criteria of pension schemes under National Social Assistance Programme (NSAP)

- i. **Indira Gandhi National Old Age Pension Scheme** – Financial assistance of ₹ 200/- per month to persons in the age group of 60-79 years and ₹ 500/- per month to persons of 80 years and above.
- ii. **Indira Gandhi National Widow Pension Scheme** - Financial assistance of ₹300/- per month to widows in the age-group of 40-79 years and ₹ 500/- per month to widows of 80 years and above.
- iii. **Indira Gandhi National Disability Pension Scheme** - Financial assistance of ₹300/- per month to persons aged 18-79 years with severe or multiple disabilities and ₹ 500/- per month to persons of 80 years and above.
