MSMEs IN ANDHRA PRADESH

122. SHRI BEEDHA MASTHAN RAO YADAV:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of MSMEs registered in last financial year, State-wise;
- (b) the number of Micro, Small and Medium Enterprises (MSMEs) being operated in Andhra Pradesh in last three years;
- (c) the number of enterprises set up in Andhra Pradesh under the Prime Minister's Employment Generation Programme scheme in the last three years, district-wise;
- (d) whether Government has assessed the reasons for not taking up the MSMEs, with key focus on the bankers non-cooperative attitude for middle income groups and rural entrepreneurs; and
- (e) if not, the reasons therefor and the steps taken for accessing credit the above categories?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a): As on 16.07.2024, the total number of MSMEs registered in last financial year on the Udyam Registration Portal was 24,914,213(including informal micro enterprises registered on Udyam Assist Platform). The State/ UTs wise details given in Annexure -1.
- (b): As on 16.07.2024, the number of Micro, Small and Medium Enterprises (MSMEs) being operated in Andhra Pradesh in last three years under Udyam Registration Portal (including informal micro enterprises registered on Udyam Assist Platform) are as follows:

(c): The number of enterprises set up in Andhra Pradesh under the Prime Minister's Employment Generation Programme scheme in the last three years was 11,127. The year wise and district wise details are attached in Annexure-II.

(d) & (e): To facilitate access to credit to MSMEs including rural entrepreneurs, the Government and Reserve Bank of India (RBI) have taken a number of initiatives vide programmes & schemes and announcements to support the MSMEs, which inter alia include (i) Collateral free loan up to a limit of Rs. 500 lakh (w.e.f. 01.04.23) to MSEs with guarantee coverage up to 85 % for various categories of loan through Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) under Credit Guarantee Scheme; (ii) inclusion of retail and wholesale traders as MSMEs for Priority Sector Lending; (iii) Co- Lending by Banks and NBFCs to Priority Sector; (iv) Restructuring of MSME loan accounts; and (v) Trade Receivables Discounting System (TReDS).

To further augment the credit facilities, Micro, Small and Medium Enterprises (MSMEs) are also being supported by the Prime Minister's Employment Generation Programme (PMEGP), a major credit-linked subsidy programme aimed at generating self-employment.

Further Government has taken a number of initiatives to support the MSME Sector. Some of them are:

- i. Rs. 50,000 crore equity infusion through Self Reliant India Fund. This scheme has a provision for corpus of Rs.10,000crore from Government of India.
- ii. New revised criteria for classification of MSMEs.
- iii. Registration of MSMEs through "Udyam Registration Portal" for Ease of Doing Business.
- iv. Non-tax benefits extended for 3 years in case of an upward change in status of MSMFs
- v. Under Vivad se Vishwas I, relief by way of refund of 95% of the deducted performance security, bid security and liquidated damages was provided to MSMEs. Relief was also provided to MSMEs debarred for default in execution of contracts.
- vi. Launch of Udyam Assist Platform (UAP) to bring the Informal Micro Enterprises (IMEs) under the formal ambit for availing the benefit under Priority Sector Lending (PSL).
- vii. Launch of 'PM Vishwakarma' Scheme on 17.09.2023 to provide end to end holistic benefits to the traditional artisans and craftspeople engaged in 18 trades, including access to subsidized credit.
