FILING UP OF VACANCIES

1319. SHRI R. GIRIRAJAN:

Will the Minister of COMMERCE & INDUSTRY be pleased to state:

(a) whether Government has taken adequate steps to fill up the vacancies falling under the Ministry and all its PSUs, subordinate and allied offices;

(b) if so, the details thereof;

(c) the incumbency position as on 1.7.2024 in respect of all aided institutes, all Public Sector Undertakings under aegis of the Ministry of Commerce and Industry; and

(d) whether Government has initiated any special recruitment drive for filling up of vacancies in SC/ST/OBC and Minority communities and if so, the details thereof, if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI JITIN PRASADA)

(a) to (d) Yes, Sir. The Ministry has taken steps to fill up the vacancies under the Ministry and all its PSUs, subordinate and allied offices. Advertisements have been issued and requisition sent to cadre controlling departments to fill up the vacancies. Department of Commerce has recruited 194 persons during the period January, 2023 to March, 2024 in the department including all its PSUs, subordinate and allied offices. The details of incumbency position as on 1.7.2024 in respect of all aided institutes & all Public Sector Undertakings under the aegis of the Ministry of Commerce and Industry are placed at Annexure. The vacancies are filled in compliance with the reservation norms/guidelines. Further, the Department of Commerce has designated officers of the rank of Deputy Secretary and above as Liaison Officers for SC/ST/OBC to ensure due compliance of order and instructions pertaining to reservation. A reservation cell has also been set up to assist the Liaison Officers in discharge of duties.
