Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) the current status of minority communities in the country in terms of socio-economic indicators such as education, employment, health, and income levels;
- (b) the specific schemes and programs implemented by the Ministry of Minority Affairs for the upliftment of minority communities in the last five years;
- (c) the quantum of fund allocated and utilized for these schemes and programs during this period; and
- (d) the details of employment statistics of minority communities in Group A services over the last five years?

ANSWER

- (a) The Government of India has been striving to improve the socio-economic status of all communities, including minority communities, through various schemes and incentives through a saturation model, thereby ensuring that socio-economic status of all communities at par with the national mainstream.
- (b) & (c) The quantum of fund allocated and utilized for specific schemes and programs implemented by Ministry of Minority Affairs for the upliftment of minority communities in last five years is annexed at Table A.
 - All the schemes together have contributed to the acquisition of higher-level skills, greater opportunities in livelihood, high employability potential, improved access to better infrastructure, and improved health overall amongst the Minority Communities.
- (d) According to DOP&T and UPSC, community-wise segregated data on Group- A service is not maintained.
