### UNDER CONSTRUCTION PROJECTS UNDER PMAY-U

#### 1485. SHRI SANT BALBIR SINGH

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) whether Government has any data regarding providing housing for all under the Pradhan Mantri Awas Yojana-Urban (PMAY-U);
- (b) if so, the details of the number of houses sanctioned/completed/grounded and allotted to the beneficiaries under PMAY-U during the last four years and current year;
- (c) the details of funds provided and utilized during the said period, year-wise and State-wise, the share of the Centre and State assistance thereto; and
- (d) the details of the under construction projects and whether any time frame has been fixed for completion of the pending projects?

### **ANSWER**

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a) to (d) 'Land' and 'Colonization' are State subjects. Therefore, schemes related to housing for their citizens are implemented by States/Union Territories (UTs). However, Ministry of Housing and Urban Affairs supplements the efforts of States/UTs by providing Central assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U) since 25.06.2015 to provide pucca houses with basic civic amenities to all eligible urban beneficiaries across the country. The scheme has four verticals namely, Beneficiary-led individual house construction/enhancements (BLC), Affordable Housing in Partnership (AHP), "In-Situ" Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS).

Houses under PMAY-U are being constructed using funds from Central assistance, State share and beneficiary contribution. Government of India is providing its fixed share as Central assistance of ₹1.0 lakh per house under ISSR and ₹1.5 lakh per house for AHP/BLC verticals of PMAY-U. The remaining cost of the house as per Detailed Project Report (DPR) is shared by States/UTs/Urban Local Bodies (ULB)/Beneficiaries.

Under CLSS vertical of PMAY-U, an interest subsidy at the rate of 6.5% which amounts upto ₹2.67 lakh per house was provided for beneficiaries of Economically Weaker Sections (EWS)/ Lower Income Group (LIG) and Middle Income Group (MIG) category.

Based on the proposals submitted by States/UTs, a total of 118.64 lakh houses have been sanctioned under PMAY-U by the Ministry as on 29.07.2024. Of the sanctioned houses, 114.40 lakh have been grounded for construction; of which 85.43 lakh have been completed/delivered and 82.19 lakh have been occupied. During the last four years and current year, a total of 49.00 lakh houses have been sanctioned, 55.81 lakh houses have been grounded for construction, 52.33 lakh houses have been completed/delivered and 51.08 lakh houses have been occupied under PMAY-U. The houses grounded/completed/occupied during the said period include houses sanctioned in the preceding years.

State/UT-wise and year-wise details of Central assistance released and utilized during the last four years and current year under PMAY-U are at Annexure-I. State/UT-wise details of houses sanctioned, Central and State share sanctioned during last four years and current year under PMAY-U are at Annexure-II.

The timeline for completion of projects varies from State to State and generally it takes 12-36 months in different verticals of the scheme and as per DPRs of respective projects. The scheme period, which was earlier upto 31.03.2022, has been extended upto 31.12.2024, except for Credit Linked Subsidy Scheme (CLSS) vertical of the scheme, to complete all the houses sanctioned without changing the funding pattern and implementation methodology. States/UTs have been advised to expedite the construction of sanctioned houses so that all houses are completed within the stipulated timeline.
