URBAN DEVELOPMENT UNDER SCM

1487. SHRI NARAIN DASS GUPTA:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of the cities to be built as smart cities and the time of the decision, details thereof, the date-wise and city-wise;
- (b) the amount of money disbursed to each smart city announced till date, the details thereof, city-wise; and
- (c) the list of the cities that have been converted into smart cities?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS
(SHRI TOKHAN SAHU)

- (a) to (c): Government of India launched the Smart Cities Mission (SCM) on 25th June, 2015. 100 Smart Cities were selected through a two-stage challenge process in 4 rounds of competition between January 2016 and June 2018. City wise details of month & year of selection of the smart cities is at Annexure.

As per SCM Guidelines, Central Government is to provide financial support to the extent of ₹48,000 crore to 100 Cities under SCM i.e., on an average of ₹ 500 crore per city. An equal amount on a matching basis is to be contributed by the State Government / Urban Local Body (ULB) other than in North-east / hilly States where the ratio is 90:10. As of 12th July, 2024, a total of ₹46,577 crore has been released as central assistance to the 100 smart cities. City wise details of funds disbursed is at Annexure.

The mission follows an Area-based smart city development (ABD) approach, concentrating the efforts in selected part (ABD area) of the city. In the Smart City proposal, every city has encapsulated its projects in ABD area and some Pan-city feature projects with Smart Solution(s). The focus of the mission has been on sustainable and inclusive development and creating replicable models. This Area-based development strategy has helped in completion of projects in shorter time frame, which are replicable in other parts of the city. As per the data provided by 100 Cities, as of 12th July, 2024, 7,218 projects amounting to ₹1,45,083 crore (90% of total projects) have been completed.
