**IMPLEMENTATION OF PM-EBUS SEWA SCHEME**

**1495. SMT. RANJEET RANJAN**

Will the Minister of Housing and Urban Affairs be pleased to state:

- a) the details of the tenders floated for the procurement of e-buses under the PM-eBus Sewa scheme, including the number of e-buses and the cities they are intended for;
- b) the current status of the procurement process and the timeline for the deployment of these e-buses;
- c) the total budget allocated for the PM-eBus Sewa scheme and the amount spent so far; and
- d) whether the Government has undertaken or plans to undertake any evaluation of the scheme's environmental impact and if so, the findings thereof?

**ANSWER**

(SHRI TOKHAN SAHU)

- (a) Tender-1 was floated by Convergence Energy Services Limited (CESL) on 17<sup>th</sup> November 2023 and Tender -2 was floated on 14<sup>th</sup> March, 2024 for PM eBus Sewa Scheme. So far total 5497 numbers electric buses have been included in Tender-1 and Tender-2. Details of the cities participated in tender-1 and tender-2 is attached as **Annexure-I**.
- (b) Tender-1 process has been completed for 1390 e-buses. Tender -2 has been invited on 14.03.2024. The timeline for deployment of buses in Tender-1 & Tender-2 is attached as **Annexure-II**.
- (c) For FY 2024-25, a total of Rs.541 crore budget has been allocated in Vote-on-Account, out of which Rs. 201.18 crore has been spent, under PM-eBus Sewa Scheme, so far.
