WELFARE SCHEMES FOR MINORITIES

1561. SHRI RAMJI LAL SUMAN: SHRI JAVED ALI KHAN:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) the details of schemes being run for welfare of minorities in the country, scheme-wise;
- (b) the details of funds allocated, released and utilized under schemes being run for the welfare of minorities during last five financial years and current financial year, year-wise, scheme-wise and State-wise; and
- (c) the details of schemes meant for minorities that have been abolished or suspended during last five years and the current year, scheme-wise and State-wise?

ANSWER

THE MINISTER OF MINORITY AFFAIRS

(SHRI KIREN RIJIJU)

(a) to (c) The Government implements various schemes for the welfare and upliftment of every strata, including minorities, specially the economically weaker and lesser privileged sections of the society. Ministry of Minority Affairs specifically implements various schemes across the country for socio-economic and educational empowerment of the six (6) centrally notified minority communities. These schemes are meant for the weaker segments of minority communities. The Schemes/programmes implemented by the Ministry are as under:

1. Educational Empowerment Schemes

During last five years, the ministry has implemented 3 Scholarship schemes namely (i) Pre-Matric, (ii) Post-Matric and (iii) Merit-cum-Means based scholarships for the students belonging to minority communities. The Right to Education (RTE) Act, 2009 makes it obligatory for the Government to provide free and compulsory elementary education (classes I to VIII) to each and every child. Hence, only students studying in classes IX and X are covered under the Pre-Matric Scholarship Scheme of other Ministries/ Departments. Likewise from 2022-23, the coverage under the Pre Matric Scholarship Scheme of Ministry of Minority Affairs has also been restricted to class IX and X only. The Post Matric Scheme covers class XI to Ph.D whereas, under the Merit-cum-Means based Scholarship scheme, technical and professional courses are

covered. The Begum Hazrat Mahal National Scholarship Scheme (BHMNS) scheme, which was only for girl child of class IX to XII has been subsumed with Pre-Matric and Post-Matric scheme, since 2022-23.

(ii) Maulana Azad National Fellowship Scheme

The Maulana Azad National Fellowship (MANF) scheme for Minority Students was launched in 2009-10 as a Central Sector Scheme. The objective of the Scheme was to provide fellowships in the form of financial assistance to students belonging to the minority communities to pursue degrees in higher education such as M.Phil and Ph.D in India. Minority students who cleared UGC-NET or Joint CSIR-UGC-NET examination were eligible for applications under Maulana Azad National Fellowship. The fellowship amount to the selected candidates was disbursed in Direct Benefit Transfer (DBT) mode and credited directly into the account of the beneficiary.

The scheme has been discontinued from 2022-23 due to its overlap with similar schemes of other Ministries. The fellowship to existing beneficiaries would continue till the completion of their studies as per extant guidelines.

(iii) Padho Pardesh - Interest Subsidy Scheme

The scheme aims to award interest subsidy on educational loan to minority students for studying abroad to pursue approved courses of study at Masters, M.Phil and Ph.D levels. Interest payable by the students, who have availed loan from a Scheduled bank under the Education Loan Scheme of the Indian Banks' Association (IBA), for the period of moratorium (i.e. course period, plus one year or six months after getting job, whichever is earlier) was borne by the Government of India.

The scheme was operational upto FY 2022-23. However, the scheme continues to provide the benefits to the existing beneficiaries till the completion of their term.

The scheme-wise details of released/disbursed during the last 5 years is as below:

(iv) Scheme for Providing Education to Madarsas/Minorities (SPEMM)

SPEMM was implemented by the Department of School Education and Literacy, Ministry of Education till 2020-21. The scheme was transferred to MoMA for implementation for 2021-22. The Scheme was approved upto 2021-22 and implemented by MoMA for 2021-22 only.

The details of funds allocated and released under SPEMM during 2018-19 to 2021-22, year-wise and State-wise is at **Annexure I.**

2. Employment and Economic Empowerment Schemes

i) 'Pradhan Mantri Virasat Ka Samvardhan (PM VIKAS)' has subsumed Seekho aur Kamao (SAK), Nai Manzil, USTTAD and Nai Roshni, schemes of the Ministry. PM VIKAS focuses on skill development; entrepreneurship and leadership of minority women; and education support for school dropouts.

The details of funds allocated, released, and utilized under the erstwhile Seekho Aur Kamao, Nai Manzil and USTTAD schemes during the last five financial years and current financial year .i.e. 2019-2020 onwards is as per the table below:

*Note: No targets have been allocated under the USTTAD and Nai Manzil scheme after 2018-19 and after 2020-21 under the Seekho aur Kamao scheme. All three skilling schemes of the Ministry viz. Seekho Aur Kamao, USTTAD and Nai Manzil have been converged into an integrated scheme called PM VIKAS. Only committed liabilities under the erstwhile schemes are being cleared.

ii) National Minorities Development and Finance Corporation (NMDFC)

NMDFC provides concessional loan to "Backward sections" amongst the notified minorities for self-employment income generation activities under its schemes of Term loan, Education loan, Virasat scheme & Micro Finance scheme through State Channelizing Agencies (SCAs) nominated by respective State Govt./ UT Administration and Canara Bank.

The details of equity contribution received from Central Govt. & concessional credit disbursed by NMDFC during the last 5 financial years and current financial year is as follows:

State-wise details of concessional credit disbursed by NMDFC during the last 5 financial years and current financial year is enclosed as "Annexure-II".

So far as NMDFC is concerned, skill training schemes namely Kaushal se Kushalta & Mahila Samridhi Yojana has been discontinued by NMDFC.

3. Infrastructure Development Scheme

(i) Pradhan Mantri Jan Vikas Karyakram (PMJVK) is a Centrally Sponsored Scheme (CSS) with the objective to develop infrastructure projects for socioeconomic development of minority population in identified areas in the country. The priority sectors under PMJVK are education, health, skill development, women centric projects, etc. The projects under the scheme are considered and approved on the basis of the proposals received from the respective State Govt. and UT Administration.

PMJVK is a demand driven scheme and State/ UT-wise allocation of funds is not made under it. However, the year-wise details of the funds released for proposals approved under PMJVK during the last five years and current financial year to all the States/UTs, is at **Annexure III**.

4. Special Schemes

(i) Jiyo Parsi: It is a central sector scheme concerning the declining Parsi population in India. Jiyo Parsi was launched in 2013-14 with an objective to reverse the declining trend of Parsi Population by adopting scientific protocol and structured interventions to stabilize their population in India.
