SMUGGLING OF NARCOTIC SUBSTANCES

#### 1832 # SHRI NEERAJ SHEKHAR:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the details of the narcotic substances seized during the last three years;
- (b) the volume of narcotic substances seized in the last three years that were smuggled through the sea route; and
- (c) the measures taken by Government to stop smuggling of narcotic substances through sea route?

#### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI NITYANAND RAI)

- a) As per latest data published by National Crime Records Bureau (NCRB) pertaining to the year 2022, the narcotic substances seized during 2020-2022 under the Narcotic Drugs & Psychotropic Substances (NDPS) Act, 1985 is at Annexure-I.
- b) As reported by various Drug Law Enforcement Agencies (DLEAs) to Narcotics Control Bureau (NCB), the volume of narcotic substances seized that were smuggled through the sea route during the last three vears is at Annexure-II.

- (c) The Government has taken various measures to stop smuggling of narcotic substances through sea route. Some of these are as under:-
- (i) A high-level dedicated group has been created in National Security Council Secretariat (NSCS) in November 2022 to analyze the drug trafficking through maritime routes, challenges and solutions (Maritime Security Group NSCS).
- (ii) To monitor coastal borders, Indian Coast Guard has also been empowered under the Narcotic Drugs & Psychotropic Substances Act, 1985 for making interdiction of narcotic drugs in coastal and high seas.
- (iii) Director General level talks by NCB are organized with neighboring and other countries such as Myanmar, Iran, Bangladesh, Indonesia, Singapore, Afghanistan, Sri Lanka, etc. to resolve various issues on drugs trafficking having international implications and issue of maritime trafficking.
- (iv) To monitor the investigation of important and significant seizures, a Joint Coordination Committee (JCC) with Director General (DG), NCB as its Chairman has been set up.
- (v) For effective coordination between various Central and State

Agencies, a new platform namely Narco Coordination (NCORD)

Centre has been established by the Government to conduct regular meeting with these agencies for effective Drug Law Enforcement. This NCORD system is 4-tier structure wherein coordination meeting are being held at National level/ State level/ District level for better ground level coordination and cooperation. The issue of maritime drug trafficking is discussed for the coastal states in which all the major port trust authorities are located.

- (vi) Representatives of Coastal Police, Port Trust as well as representatives from Indian Navy and Indian Coast Guard have been included as member of the State Level NCORD Committee. Representatives of Indian Coast Guard and Port authorities have also been included in District Level Committee of NCORD meetings.
- (vii) A dedicated Anti Narcotics Task Force has been constituted in all States and Union Territories of the country for taking coordinated and concerted action related to trafficking of drugs including smuggling through maritime routes.
