SHARING OF TOLL REVENUE

1863. DR. KANIMOZHI NVN SOMU:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) whether it is a fact that, user fee is collected for approximately 45,000km of National Highways and Expressways at around 1,000 toll plazas from around 8 crore FASTag users across the country and if so, the details thereof and the collection made State-wise;
- (b) whether Government has any plan to share the toll income generated with the respective State Governments where the toll plaza is located and, if so, the details thereof; and
- (c) the details of sharing pattern of income from the toll plazas across the country?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

- (a) As on 30.06.2024, State-wise details of user fee collection at 983 nos. of fee plazas on approx. 48,452 Kilometers tolled length of National Highways are at Annexure.
- (b) The revenue generated through user fee is collected by User Fee Collecting Agencies (UFCAs), appointed through bidding in respect of Public Funded fee plazas, and the agreed remittance as per Contract Agreement is deposited by the UFCA into National Highways Authority of India (NHAI) account which is transferred to Consolidated Fund of India (CFI). In respect of Concessionaire fee plazas, the user fee is collected by the Concessionaire as per respective user fee notification and same is either retained or transferred to NHAI as per the respective Concession Agreement. In case of transfer of any fee collected by the Concessionaire to NHAI, the same is also deposited in CFI.
- (c) Does not arise.
