**EKALAVYA MODEL RESIDENTIAL SCHOOLS (EMRS) IN TELANGANA**

1895 SHRI ANIL KUMAR YADAV MANDADI:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the details of sanctioned Ekalavya Model Residential Schools (EMRS) in the State of Telangana;
- (b) the details of operational EMRS and sanctioned teachers strength in those schools; and
- (c) the details of funds allocated for operation of these schools in the State of Telangana and funds released to these schools during the last five years?

**(a) and (b):** Ministry of Tribal Affairs has approved 23 Eklavya Model Residential Schools (EMRS) in the State of Telangana and all are reported to be operational as on date. The details of these schools are provided at **Annexure**. A total number of 52 posts (Teaching and Non-Teaching) per EMRS have been sanctioned by Department of Expenditure, Ministry of Finance.

**(c):** Earlier EMRS was a component under Article 275(1) of the Constitution and till the year 2019-20 fund was released under Article 275(1) for EMRS along with other activities sanctioned under the programme. The new central sector scheme of EMRS was carved out in the year 2018-19 and National Education Society for Tribal Students (NESTS), an autonomous society, was created in the year 2019 to manage and implement the scheme of EMRS. Ministry releases funds to NESTS which releases funds to States/ UTs/ PSUs/ Construction Agencies/ State Societies as per their requirements for construction of EMRSs and recurring cost for running of the schools. As reported by NESTS, funds sanctioned/ released for EMRSs in Telangana from 2020-21 to 2023-24 (both recurring and non-recurring) are as under:
