Will the Minister of Women and Child Development be pleased to state:

- (a) the details of activities and fund provided by the National Commission for Women (NCW) to Punjab State Commission for Women and utilization/status of programme/activities during the last three years and the current year;
- (b) whether the National Commission of Women is planning to allocate funds to Punjab State Women Commission in upcoming year;
- (c) if so, the details thereof and if not, the reasons therefor; and
- (d) the details of fund allocation made to various State Women Commissions, Statewise?

#### **ANSWER**

### MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

- (a) National Commission for Women (NCW) informed that no fund has been allocated/provided to Punjab State Commission for Women during the last three years and the current year.
- (b) to (c) No advance planning to allocate fund to the State Women Commissions is done by the NCW. The Commission considers allocation of funds to the State Women Commissions for various programme/activities as and when such request is received from them. NCW did not receive any proposal from Punjab State Commission for Women in the last three years for consideration of sanctioning of funds.
- (d) The details of State-wise fund allocation to the State Women Commissions for various programmes/activities from FY 2020-21 to FY 2023-24 are attached as an **Annexure-I**
