### Status of Nagar Van Yojana in Odisha

1987. SHRI MANAS RANJAN MANGARAJ:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the present status of the Nagar Van Yojana with reference to the State of Odisha;
- (b) the total urban area of the country in which tree plantation has been carried out so far, the details thereof, State-wise, including the cities of Odisha, covered under the said Yojana; and
- (c) the total funds allocated by Central Government to Odisha during the last two years and the current year, under the said Yojana?

#### **ANSWER**

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI KIRTI VARDHAN SINGH)

- (a) The Nagar Van Yojana envisages creating a Nagar Van/Nagar Vatika in each City having Municipal Corporation /Municipal council /Municipality /Urban Local Bodies (ULBs) for providing wholesome healthy living environment for the residents and thus contributing to growth of clean, green, healthy and sustainable cities. Ministry has approved 40 Nagar Van/Vatika projects in Odisha with an outlay of Rs.29.05 crores and the first instalment of Rs. 20.34 Crores was released during the years 2020-21 and 2021-22.
- (b) The total urban area of sanctioned projects under Nagar Van Yojana in the country is 12198 Ha which includes areas marked for fencing, soil-moisture conservation measures, administrative activities, and plantation. The State-wise details including Odisha, is enclosed as **Annexure-I**
- (c) No funds have been released to Odisha during the last two years and the current year, under the said Yojana
