IMPLEMENTATION OF PM-KISAN

2109. Shri Randeep Singh Surjewala:

Will the Minister of Agriculture and Farmers Welfare be pleased to state:

- (a) the total number of beneficiaries under Pradhan Mantri Kisan Samman Nidhi (PMKISAN), from 2019 till date, year-wise, State-wise;
- (b) whether it is a fact that the number of beneficiaries under PM-KISAN has decreased since 2019, if so, the details thereof year-wise and State-wise;
- (c) the funds allocated and utilised under the same since 2019, year-wise and State-wise; and
- (d) the funds allocated and utilised for publicity of PM-KISAN since 2019?

ANSWER

MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE (SHRI RAMNATH THAKUR)

(a) to (d): The PM-KISAN scheme is a central sector scheme launched in February 2019 by the Hon'ble Prime Minister to supplement the financial needs of land-holding farmers. Under the scheme, a financial benefit of Rs 6,000/- per year is transferred in three equal instalments, into the Aadhaar seeded bank accounts of farmers through Direct Benefit Transfer (DBT) mode. The PM-KISAN scheme is one of the largest DBT Scheme of the World.

A farmer-centric digital infrastructure has ensured the benefits of the scheme reach all the farmers across the country without involvement of any middlemen. Maintaining absolute transparency in registering and verifying beneficiaries, the Government of India has disbursed over Rs 3.24 lakh Cr to more than 11 Cr farmers in 17 installments since inception.

As per operational guidelines of the Scheme, States/UTs are mandated to identify and verify the eligible beneficiaries under the scheme and upload the details of eligible farmers including land records, linking of Aadhaar with their bank accounts and e-KYC for successful transfer of the benefits. Benefits of

the scheme are transferred to the beneficiaries through Direct Benefit Transfer (DBT) mode, based on the verified data received from the States/UTs on the PM-KISAN portal.

To ensure that the benefits are provided only to the intended beneficiaries, e-KYC, land seeding, and Aadhaar-based payment have been made mandatory under the scheme. Land seeding was made mandatory during the release of the 12th installment of the scheme (August 2022 - November 2022), and Aadhaar-based payment was made mandatory from the 13th installment (December 2022 - March 2023) onwards. e-KYC was made mandatory from the 15th installment (April 2023 - July 2023). In this process, initially the total numbers of beneficiaries benefited in the scheme were decreased across the country. However, this decrease was nominal in the States who proactively undertook suitable measures and completed the above said mandatory requirements.

The Ministry often undertakes saturation drives in coordination with the State Governments to ensure that no eligible farmers are left out from the Scheme. The recent nationwide saturation drive was undertaken from 15 November 2023, under the Viksit Bharat Sankalp Yatra (VBSY), to saturate the scheme with all eligible farmers. More than 1.0 cr farmers were included in the scheme during the campaign period across the country. The 17th installment of PM-KIsan Scheme was released in June, 2024 to more than 9.26 Cr. farmers amounting to more than Rs. 20,000 Cr.

The validation checks of land seeding, Aadhaar linking with bank accounts, eKYC and payment to the eligible beneficiaries are ongoing processes. As and when the farmers complete the mandatory requirements, they receive benefits of all outstanding instalments. Hence, there is no loss to the beneficiaries.

Under the PM-Kisan scheme, funds are not allocated State-wise. The benefits of the scheme is disbursed directly into Aadhaar seeded bank account of the beneficiary. The State-wise, year-wise data of funds released under PM-KISAN since its inception is attached at Annexure.

The Government of India and state governments undertake several activities for the publicity of PM-KISAN, including print advertisements in newspapers at regular intervals, outreach through social media, programs on DD Kisan, etc. Furthermore, the Ministry also provides administrative expenses to the States/UTs for the implementation of PM-KISAN, including publicity/awareness drives. As of today, a total administrative expense of Rs. 206.34 crore has been provided to States/UTs since the inception of the scheme.
