## FOOD PROCESSING PROJECTS IN TAMIL NADU

### 2150. SHRI M. MOHAMED ABDULLA:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

(a) the number of food processing projects started in the State of Tamil Nadu in the last five years;

(b) the status of those projects including their tentative date of completion, and the extent of financial support provided by Government;

- (c) whether Government has taken any steps to encourage more projects in Tamil Nadu; and
- (d) if so, the details of the projects proposed and funds allocated to State of Tamil Nadu?

### ANSWER

# THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a) & (b). The Ministry of Food Processing Industries (MoFPI) does not setup any food processing Industries on its own. However, it incentivizes setting up of such industries through its schemes. The details of projects approved in Tamil Nadu state is placed at **Annexure**.

(c) & (d). In order to ensure overall development of Food Processing Industries in the country including Tamil Nadu, MoFPI has been incentivizing setting up/expansion of related infrastructure through its Central Sector Schemes named Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), and Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally sponsored Prime Minister Formalization of Micro Food Processing Enterprises (PMFME) scheme.

Under sub-schemes of PMKSY has an allocation of Rs.5520 crore for the 15th Finance Commission cycle. MoFPI provides mostly credit linked financial assistance (capital subsidy) in the form of grants-in-aid to entrepreneurs selected on the basis of Expression of Interest (EoI) issued from time to time under PMKSY, which is not any region or state specific but demand driven and implemented across the country. Projects sanctioned under sub-schemes of PMKSY normally have a completion timeline of two years.

PLISFPI, inter alia, is intended to support creation of global food manufacturing champions and support Indian brands of food products in international market. The Scheme is being implemented over a six-year period from 2021-22 to 2026-27 with an outlay of Rs.10,900 crores. PLISFPI is also not any region or state specific but demand driven and implemented across the country.

Ministry provides financial, technical and business support for setting up/ upgradation of 2 lakh micro food processing enterprises under PMFME, which is also a demand driven scheme. The scheme is operational for a period of five years from 2020-21 to 2024-25 with an outlay of Rs.10,000 crore. Rs.50 crore has been earmarked for Tamil Nadu for 2024-25, which is subject to modification/adjustments as per needs. A tentative target for sanctioning of credit linked subsidy to 8500 micro food processing enterprises for 2024-25.
