- (c) the details of budget utilised as well as unspent balances along with the implementing agencies under PMAY-G during last five years; and
- (d) whether there is any special grants to be released to State of Karnataka by Government for completing the targets under PMAY-G?

(a) to (d): The State-wise targets set and achievements under Pradhan Mantri Awas Yojana - Gramin (PMAY-G) since inception is given in **Annexure-I**.

Under Pradhan Mantri Awas Yojana - Gramin (PMAY-G), the Ministry releases Central Share of funds directly to State/UT considering them as a single unit. Further disbursement of funds as installments of assistance to the beneficiaries is done by the State. The details of Central Share released & funds utilized (including State Share) under PMAY-G during the last five years 2019-20 to 2023-24, State-wise is given in **Annexure-II**.
