PARTICIPATION OF WOMEN IN MGNREGA

2207 SHRI C. VE. SHANMUGAM:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether the participation of women in the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) has come down to its five year low level;
- (b) if so, the details thereof for the last five years, year-wise;
- (c) whether as per the provisions of MGNREGS the women should be given priority, therefore, one-third of its beneficiaries should be women;
- (d) if so, whether the said provision has been complied with by the States; and
- (e) if so, the details of such States?

(a) & (b): No. The rate of participation of women in Mahatma Gandhi NREGS during the last five financial years at the National level is given below:

(c)to(e): Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand-driven wage employment Scheme. However, as per Para 15 of Schedule-II of the Mahatma Gandhi National Rural Employment Guarantee Act, "Priority shall be given to women in such a way that at least one-third of the beneficiaries shall be women who have registered and requested for work.

This provision is intended to promote gender equality and ensure that women have equitable access to employment opportunities under the scheme.

State/UT-wise rate of participation of women in Mahatma Gandhi NREGS during the last five financial years from 2019-20 to 2023-24 is given at Annexure.

The responsibility of implementation of the Mahatma Gandhi NREGS is vested with the Government of States/UTs. However, the Ministry has a comprehensive system of monitoring and review mechanisms under Mahatma Gandhi NREGS. The Ministry regularly reviews the performance of the implementation of Mahatma Gandhi NREGS on various parameters, including women's participation with States/UTs through Mid-Term Review, Annual Action Plan, Labour Budget Revision meetings and Performance Review Committee Meetings etc.
