#### EMERGENCY CREDIT LINE GUARANTEE SCHEME

#### 2232. SHRI P. WILSON:

Will the Minister of TEXTILES be pleased to state:

- (a) whether Government has considered request of spinning mill associations to extend moratorium period for repayment of loan and grant relaxation under Emergency Credit Line Guarantee Scheme (ECLGS) taking into view that textile industry is facing severe crisis as cotton export has reduced drastically by 50 per cent;
- (b) whether Government has considered reducing 11 per cent import duty levied on cotton in order to make it competitive with overseas market, if not, the reasons therefor; and
- (c) the details of steps taken for revival of textile industry and funds disbursed under ECLGS in the last five years?

#### **ANSWER**

# THE MINISTER OF STATE FOR TEXTILES (SHRI PABITRA MARGHERITA)

(a): There is an increase of 19% in export of Cotton Textiles during FY: 2023-24 with respect to FY: 2019-20. Details are as under:

Loan under ECLGS was only a portion of the total loan outstanding of a borrower and was made available to businesses to meet their immediate liquidity issues. The Scheme of ECLGS has since closed. No extension in moratorium has been provided to any category of business under ECLGS as that would amount to restructuring of a loan and downgrading of the account to NPA.

- **(b):** Currently, import of raw cotton attracts 11% Customs duty (5% Basic Custom Duty + 5% Agriculture Infrastructure and Development Cess + 10% of Social Welfare Surcharge). With effect from 20<sup>th</sup> February 2024, the custom duty on Extra-Long Staple (ELS) Cotton has been reduced to NIL. Further, under the India-Australia ECTA, 51,000 tonnes of duty free ELS Cotton can be imported since Dec 29, 2022.
- (c): Government is implementing various schemes viz, Production Linked Incentive (PLI) Scheme, Pradhan Mantri Mega Integrated Textile Region and Apparel (PM MITRA), SAMARTH (Scheme for Capacity Building in Textile Sector), Silk Samagra, National Handloom Development Programme, National Handicraft Development Programme, Integrated Wool Development Programme (IWDP), National Technical Textile Mission (NTTM) etc. catering exclusively for development of textile sector in the country.
