UTILIZATION OF NIRBHAYA FUND

257. MS. KAVITA PATIDAR:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) the amount allocated by the Government for Madhya Pradesh towards the Nirbhaya Fund for the year 2024-25;
- (b) the number of Vehicle Location Tracking Device Systems installed by the Transport Department of Madhya Pradesh for the safety of women/girls through this fund in coordination with the Central Government and the State Government;
- (c) the district-wise details in this regard; and
- (d) the location of its Command and Control Centre in Madhya Pradesh?

- (a) and (d) An amount of Rs. 4.192 crore has been allocated to Transport Department, Government of Madhya Pradesh on 07.03.2022 under the Scheme "Development, Customization, Deployment and Management of State-wise vehicle tracking platform for Safety & Enforcement as per AIS 140 Specifications in States / UTs under Nirbhaya Framework" for setting up the Monitoring Centre in Bhopal. This Ministry has not received any request for allocation of funds from the State of Madhya Pradesh in the financial year 2024-25 so far.
- (b) and (c) Under the above Scheme, funds are provided to State/ UT Governments to establish Monitoring Centres so as to effectively implement the monitoring of vehicle tracking system in public service vehicles. The Vehicle Location Tracking Devices (VLTD) are installed by the respective vehicle owners. RTO-wise details of VLT Devices fitted in vehicles in the State of Madhya Pradesh as on 15/07/2024 are provided in the Annexure.
