SCHEMES FOR TRIBALS IN GOA

- (a) the details of the schemes benefiting Tribals in the State of Goa; and
- (b) the number of beneficiaries under different schemes in the State of Goa, the details thereof?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY)

- (a): Details of major schemes/programs implemented by the Ministry of Tribal Affairs in the State of Goa are as under.
- (i). Pre and Post Matric Scholarship Schemes
- (ii). Pradhan Mantri Adi Adarsh gram Yojana
- (iii). Scheme of Support to TRIs
- (iv). Administrative Grants to States.

Over and above these Centrally Sponsored schemes, the tribal from Goa can also take benefit of National Scholarship Scheme, National Fellowship Scheme, National overseas Scholarship Scheme, Grants to NGO and Pradhan Mantri janjatiya Vikas Mission.

Further Government is implementing Development Action Plan for Scheduled Tribes (DAPST) as a strategy for the development of Scheduled Tribes and areas having tribal concentration. Besides Ministry of Tribal Affairs, 41 Ministries/Departments are allocating certain percentage of their total scheme budget every year for tribal development under DAPST for various tribal development projects relating to education, health, agriculture, irrigation, roads, housing, electrification, employment generation, skill development, etc. Schemes along-with funds allocated by the obligated Ministries/Departments for the welfare of Scheduled Tribes.
