LOANS UNDER MODIFIED INTEREST SUBVENTION SCHEME

517. Shri Manoj Kumar Jha:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the total amount of short term loans disbursed under the Modified Interest Subvention Scheme (MISS) till date, year-wise and State-wise;
- (b) the total number of farmers offered such loans and the number of loans in progress;
- (c) the total number of farmers who availed the subvention option;
- (d) whether loans were provided in case of natural calamities, if so the details thereof; and
- (e) the total amount of post harvest loans provided to farmers till date, year-wise?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE

(SHRI SHIVRAJ SINGH CHOUHAN)

- (a) : Modified Interest Subvention Scheme (MISS) is to provide Interest Subvention (IS) and Prompt Repayment Incentive (PRI) benefit on short term loan taken by farmers under Kisan Credit Card (KCC). Total year wise and State-wise short term loan disbursed since 2021 onwards is given at annexure-1(A to C), which includes beneficiaries of MISS as well.
- (b) : Total short term loan accounts year-wise and State-wise is given at annexure-1(A to C). No consolidated data of under - process loans is maintained at any single point and thus not available.
- (c) : The number of eligible accounts for Interest Subvention (IS) and / or PRI benefits during 2021-22 is 5.25 Crores and 2022-23 is 5.52 Crores.
- (d): :In order to provide relief to farmers affected by natural calamities, MISS guidelines provide an interest subvention in the first year on the restructured loan amount. Such restructured loan attracts normal rate of interest from the second year onwards as per extant policy laid down by the RBI. To provide relief to the farmers affected due to severe natural calamities

provision for an interest subvention is available for first three years/entire period (subject to a maximum of five years) on the restructured loan amount. Further, in all such cases, the benefit of prompt repayment incentive @ 3% per annum is also available to the affected farmers. The grant of such benefit in cases of severe natural calamities shall, however, be decided by a High Level Committee (HLC) based on the recommendations of Inter-Ministerial Central Team (IMCT) and Sub Committee of National Executive Committee (SC-NEC).

- (e): The provision of post harvest loan component of KCC is included in the overall disbursed amount of KCC and not maintained separately.
