- (a) The States in the country having coal reserves;
- (b) the policy of Government, at present, for handing over the work of extraction from coal mines to private companies; and
- (c) the private companies that have been allotted leases for the extraction from coal mines in the country and the details of the terms for the allocation of coal mines, Statewise?

ANSWER MINISTER OF COAL AND MINES (SHRI G. KISHAN REDDY)

(a): The state-wise coal resource as per the National Inventory of "Indian Coal and Lignite Resources" updated up to 01.04.2023 by GSI is given below -

- (b): As per present policy of government, the coal mines are being allocated for sale of coal through transparent and fair auction process, where both Private and Government companies can bid for the mine on revenue sharing basis.
- (c): Details of coal mines allocated to private companies is enclosed as **Annexure**. The details of Terms of allocation as per allotment order are as under:-

- (i) Upon allocation of coal block, the allocattee has to obtain statutory clearances from Central and State Government and operationalize the coal block as per time- schedule prescribed in Coal Mine/Block Development & Production Agreement (CMDPA/CBDPA).
- (ii) The fully explored blocks has to be operationalized within 51 months and regionally explored blocks has to be operationalized within 66 months from issuance of allocation order.
- (iii) The performance of allocattee, in development of coal block, is monitored on the basis of efficiency parameters/Milestones, given in CMPDA and delay attributable to allocattee leads to forfeiture of fix percentage of performance security submitted by allocattee.
