**EXTENSION OF METRO RAIL NETWORK**

**694. SHRI KESRIDEVSINH JHALA:**

**SHRI BABUBHAI JESANGBHAI DESAI:**

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether Government is planning to extend metro rail network and housing development on top priority under urban development strategy;
- (b) if so, the details thereof;
- (c) the list of cities where the metro rail network is proposed to extend; and
- (d) the details of funds allocated and utilized for developing metro rail networks and housing facility during 2021 to 2024, State-wise?

**ANSWER**

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS  
(SHRI TOKHAN SAHU)

(a) & (b) 'Urban planning' and 'Colonization' are State subjects. Therefore, the respective State Governments are responsible for planning, initiating and developing urban infrastructure including metro rail projects and implementation of schemes related to housing.

As per Metro Rail Policy, 2017, Central Government considers financial assistance for Metro Rail proposals in cities or urban agglomerates based on the feasibility of the proposal and availability of resources, as and when posed by the concerned State Government.

Also, Central Government has been supplementing the efforts of States/Union Territories (UTs) since June 25, 2015 by providing Central Assistance under Pradhan Mantri Awas Yojana – Urban (PMAY-U) to provide pucca house in urban areas across the country through four verticals i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), In-Situ Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS). A total of 118.64 lakh houses have been sanctioned by the Ministry, out of which, 114.33 lakh have been grounded and 85.04 lakh are completed/delivered to the beneficiaries across the country as on 15.07.2024. The scheme has been extended till 31.12.2024, except CLSS vertical of the scheme, to complete all the houses sanctioned without changing the funding pattern and implementation methodology.

(c) Presently, expansion of Metro Rail network is at construction stage in Delhi, Gurugram, Bangalore, Kolkata, Chennai, Kochi, Mumbai, Nagpur, Ahmedabad, Pune, Kanpur and Agra. Further, implementation of Metro Rail Network is at construction stage in Gandhinagar, Bhopal, Indore, Patna, Surat and Meerut.

(d) The details of funds released to various Metro Rail Corporations by this Ministry for developing metro rail network, during the last three years and current year, State-wise, are given in Annexure-I. The details of Central Assistance released during the last three years and current year, State-wise, under PMAY-U are at Annexure-II.
