(a): The aim of 'A Scheme for Promotion of Innovation, Rural Industry and Entrepreneurship' (ASPIRE) is to set up a network of Livelihood Business Incubators (LBIs) with the objective to generate employment opportunities by facilitating formal, scalable micro-enterprise creation in agro-rural sector through skill development and incubation programmes.
