HOUSES BUILT UNDER PRADHAN MANTRI AWAS YOJANA

75. SHRI ABDUL WAHAB

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) the number of houses built under 'Pradhan Mantri Awas Yojana' in the last five years, district-wise, State-wise and year-wise;
- (b) the fund allocated to build houses under Pradhan Mantri Awas Yojana in the last five years, Statewise, year-wise; and
- (c) the average cost of building a single house under Pradhan Mantri Awas Yojana, State-wise, year-wise for the last five years?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

(a) 'Land' and 'Colonization' are State subjects. Therefore, schemes related to housing for their citizens are implemented by States/Union Territories (UTs). However, Ministry of Housing and Urban Affairs supplements the efforts of States/UTs by providing Central assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U) since 25.06.2015 to provide pucca houses with basic civic amenities to all eligible urban beneficiaries across the country through four verticals, i.e. Beneficiaryled individual house construction/ enhancement (BLC), Affordable Housing in Partnership (AHP), 'In-situ' Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS).

Based on the project proposals submitted by States/ UTs, as on 15.07.2024, 118.64 lakh houses have been sanctioned under PMAY-U, out of which 114.33 lakh have been grounded for construction; of which 85.04 lakh have been completed/delivered to beneficiaries. Out of ₹ 2.00 lakh crore (approx.) Central assistance committed, ₹ 1.64 lakh crore has been released so far.
