**“Status of AYUSH drug manufacturing in the country”**

**815. Shri. K. R. N. Rajeshkumar**

Will the Minister of *Ayush* be pleased to state:

- (a) the schemes implemented, and methodology established to ensure quality control and standardization of AYUSH drugs;
- (b) whether any action was taken in the last five years against misleading advertisements for treatment and drugs, if so, the details thereof; and
- (c) whether there are any subsidies or incentives for manufacturing AYUSH drugs and, if so, the details thereof?

**ANSWER**

**THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYUSH  
(SHRI PRATAP RAO JADHAV)**

(a) and (c) In the year 2021, Ministry of Ayush has implemented a Central Sector Scheme Ayush Oushadhi Gunavatta evam Utpadan Samvardhan Yojana (AOGUSY). The total financial allocation to this scheme is Rs. 122.00 crores for five years. The components of AOGUSY scheme are as follows: -

A. Strengthening and up-gradation of Ayush Pharmacies and Drug Testing Laboratories to achieve higher standards.

B. Pharmacovigilance of ASU&H drugs including surveillance of misleading advertisements.

C. Strengthening of Central and State regulatory frameworks including Technical Human Resource & Capacity Building programs for Ayush drugs.

D. Support for development of standards and accreditation/certification of Ayush products & materials in collaboration with Bureau of Indian Standards (BIS), Quality Control of India (QCI) and other relevant scientific institutions and industrial R&D centers.

The objectives of the Scheme are as under;

- i. To enhance India's manufacturing capabilities and exports of traditional medicines and health promotion products under the initiative of Atmanirbhar Bharat.
- ii. To facilitate adequate infrastructural & technological upgradation and institutional activities in public and private sector for standardization, quality manufacturing and analytical testing of Ayush drugs & materials.
- iii. To strengthen regulatory frameworks at Central and State level for effective quality control, safety monitoring and surveillance of misleading advertisements of Ayush drugs.
- iv. To encourage building up synergies, collaborations and convergent approaches for promoting standards and quality of Ayush drugs & materials.

Further for release of Grand-in-aid All India Institute of Ayurveda, New Delhi, AIIA is designated as Central Nodal Agency. The details of grant are annexed as **Annexure-I**.

The Drugs & Cosmetics Act, 1940 and Rule made there under have exclusive regulatory provisions for Ayurvedic, Siddha, Unani, and Homoeopathy drugs. Provisions relating to Ayurveda, Siddha and Unani Drugs are contained in Chapter IVA and Schedule- I of the Drugs and Cosmetics Act, 1940 and in Rules 151 to 169, Schedules E(I), T & TA of the Drugs and Cosmetics Rules, 1945. Further Second Schedule (4A) of the Drugs and Cosmetics Act, 1940 provides standards for Homoeopathic drugs and Rules 2dd, 30AA, 67 (C-H), 85 (A to D), 106-A, Schedule K, Schedule M-I of the Drugs and Cosmetics Rules, 1945 pertain to Homoeopathic drugs. It is mandatory for the manufacturers to adhere to the prescribed requirements for licensing of manufacturing units & medicines including proof of safety & effectiveness, compliance with the Good Manufacturing Practices (GMP) as per Schedule T & Schedule M-I of

Drugs and Cosmetics Rules, 1945 and quality standards of drugs given in the respective pharmacopoeia.

(b) Pharmacovigilance Centres for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) Drugs set up in different parts of the country under the Central Scheme of Ministry of Ayush are mandated to monitor and report the misleading advertisements to the respective State Regulatory Authorities. The program is working through a three-tier network of a National Pharmacovigilance Centre (NPvCC), Five Intermediary Pharmacovigilance Centers (IPvCs) and 99 Peripheral Pharmacovigilance Centers (PPvCs) established across the country. All India Institute of Ayurveda (AIIA), New Delhi under Ministry of Ayush is the National Pharmacovigilance Co-ordination Centre (NPvCC) for the implementation of the National Pharmacovigilance program for Ayurveda, Siddha, Unani & Homoeopathy drugs. Objectionable advertisements are being reported to the respective State Licensing Authorities by PPvC at regular intervals.

The vision of the program is to improve patient safety in Indian population by monitoring the drug safety in ASU & H drugs and thereby reducing the risk associated with use of these drugs. Further, the program focusses upon generating awareness among various stakeholders, inculcating reporting culture of suspected adverse effects and surveillance of misleading advertisements appearing in the print and electronic media. To generate awareness regarding the Ayush therapeutic approaches and educate about the systematic use of Ayush drugs, and to inculcate the reporting of any suspected adverse drug reaction in healthcare professionals; awareness events are being regularly organized across the country. Since 2018, the center has started receiving suspected reactions. These are the individual case safety reports and can be signals for future reference. These are being recorded and submitted to Drug Policy Section, Ministry of Ayush for information. Reporting Objectionable advertisements to the respective State Licensing Authorities are an objective of the program.

Under the Pharmacovigilance program till date a total of 38539 misleading advertisements related to Ayush drugs has been noticed and reported to the SLAs for possibility of action against the defaulter's details are available at Annexure-II.

These reports are mild in nature. None of them were found to be serious and none required hospitalization. No fatality was noticed, and all the reports were self-limiting and non-serious in nature.

Also, as per National Commission for Indian System of Medicine Regulations, 2022 and National Commission for Homoeopathy regulations, 2022, Pharmacovigilance is a mandate component for all the Ayush system of medicine. Also, 1500 awareness programs have been conducted with 115283 beneficiaries,
