(a) to (c) : The legal framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. The CSR Framework under the Companies Act, 2013 ('the Act') is disclosure based and CSR mandated companies are required to file details of CSR activities annually in the MCA21 registry. **The details of the CSR spent by companies under Corporate Social Responsibility (CSR) in the State of Himachal Pradesh for last three years is given below:-**
