JAL JEEVAN MISSION-URBAN IN THE STATE OF JHARKHAND

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of works completed under the Jal Jeevan Mission-Urban (JJM-U) in the State of Jharkhand during the last five years ;
- (b) the amount sanctioned, allocated, and spent for these works during the last five years;
- (c) the number of households which have been provided with tap water under JJM(U) in the State of Jharkhand so far; and
- (d) the steps being taken to ensure availability of tap water in every household at the earliest?

ANSWER

(a): The proposed Jal Jeevan Mission Urban scheme has been launched as Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 for a period of 05 years i.e. from the financial year 2021- 22 to 2025-26. The mission aims at making the cities 'water secure' and provide universal coverage of water supply through functional taps to all households in all the statutory towns in the country. Mission also aims at providing sewage/ septage management to all households of 500 cities covered in first phase of the AMRUT scheme.

In Jharkhand, 113 projects worth ₹4,202.53 crore have been approved by Ministry of Housing & Urban Affairs (MoHUA) under AMRUT 2.0 so far, which include 17 Water Supply projects worth ₹1,782.03 crore, 1 Sewerage Septage Management projects worth ₹2,284.02 crore, 70 Water Body Rejuvenation projects worth ₹106.28 crore & 25 Parks and Green Spaces projects worth ₹30.19 crore. As reported by the State, Detailed Project Reports (DPRs) for 49 projects worth ₹321.43 crore have been approved, Notice Inviting Tenders (NITs) of 13 projects worth ₹529.19 crore have been issued. 41 projects worth ₹716.83 crore contracts have been awarded and 4 projects worth ₹3.85 crore have been completed.

(b): The funds under AMRUT 2.0 are released to States/Union Territories (UTs), State Water Action Plan-wise respectively and not project-wise. Funds released and Utilization Certificate (UCs) received in last 5 Years under AMRUT for projects is as under:

(c) & (d): AMRUT 2.0 covers all the statutory towns of the country to ensure universal coverage of water supply & make cities 'water secure'. 2.15 lakh new & serviced tap connections have been proposed through the approved projects in Jharkhand till date under AMRUT 2.0. However, under AMRUT, State has informed that 2.99 lakh water tap connections are provided under AMRUT & in convergence in the State of Jharkhand
