(b) the data for sourcing of meat for exports, category-wise, State-wise;

(c) the list of top 20 exporters of meat in terms of volume;

(d) the steps taken by Government to boost meat exports from India in the last three years; and

(e) whether Government has taken note of cow-vigilantism or certain State legislations harming the meat export sector in India, if so, in what manner does Government intend to tackle the issues?

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF RAJYA SABHA STARRED QUESTION NO. 128 FOR ANSWER ON 06<sup>th</sup> DECEMBER, 2024 REGARDING "MEAT EXPORTS FROM INDIA"

(a) & (b) The data on meat exports from India in both volume and value terms during the last three years (category-wise) is annexed at **Annexure 1**. The government maintains record of total meat exports from India. The data for State wise exports of meat is based on the State-of-origin code reported by the exporters in the shipping bills. The State-wise and category wise meat exports data is annexed at **Annexure 2**.

(c) As per the Data Dissemination Policy, the Directorate General of Commercial Intelligence & Statistics (DGCI&S) maintains the confidentiality of exporters/importers' information of commercial sensitive data and prohibits the disclosure of information on identity particulars of exporters/importers like Name and IE Code Numbers. However, the information regarding the exporters of meat of different categories which is as per the returns filed by the exporters to Agricultural and Processed Food Products Export Development Authority(APEDA) can be accessed at https://apeda.gov.in/apedawebsite/Statistics/Top\_20\_exporters.htm

(d) Department of Commerce, Ministry of Commerce & Industry through Agricultural and Processed Food Products Export Development Authority(APEDA), provides financial assistance to its registered exporters through its Financial Assistance Scheme (FAS) which aims to facilitate the export of agricultural products including meat and meat products under the following components:

- i. Development of Export Infrastructure
- ii. Quality Development
- iii. Market Development

The details of financial assistance guidelines are available at APEDA Website <u>www.apeda.gov.in</u> under the "Scheme" tab.

Further, The Department of Animal Husbandry and Dairying supports States and UTs through the Livestock Health and Disease Control Programme, which aims to reduce animal health risks through vaccination, capacity building, disease surveillance, and strengthening veterinary infrastructure. This helps to boost livestock product exports, including meat.

(e) As per the Foreign Trade Policy, export of beef which includes meat and edible offal of cows, oxen and calves is prohibited. The department is not in receipt of any State legislation impacting meat exports.
