WORKS TAKEN UP BY NHAI

178. DR. JOHN BRITTAS:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:-

- (a) the status and targeted dates of completion of works taken up by the NHAI in the State of Kerala, details thereof;
- (b) the details of funds borne by various State Governments for works taken up by NHAI during the last three years;
- (c) funds contributed and agreed to be contributed by States till date for development of Highways including land acquisition cost, State-wise, year-wise details thereof;
- (d) whether Government of Kerala has requested to Union Government to exonerate the State from bearing portion of cost for certain roads; and
- (e) if so, the details of such roads and current status thereof?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF RAJYA SABHA STARRED QUESTION NO. 178 ANSWERED ON 11TH DECEMBER, 2024 ASKED BY DR. JOHN BRITTAS REGARDING 'WORKS TAKEN UP BY NHAI'.

(a) The details are annexed.

(b) to (c) The development of National Highways is a continuous process. Projects are sanctioned based on the fulfillment of the criteria, requirement of connectivity, inter-se priority, availability of resources and synergy with PM Gati Shakti National Master Plan.

In certain cases, in order to improve viability of the project, State governments of Assam, Haryana, Karnakata, Kerala, Madhya Pradesh, Uttar Pradesh and many other States has agreed to share cost towards land acquisition and/or utility shifting, reimbursement of royalty and State component of GST etc. Such agreements are project specific.

(d) to (e) The State Government has requested to exempt the share of 25 percent of the land acquisition for National Highway Development project is the State of Kerala. In response, Ministry has requested to consider exemption of royalty, State Components of GST to make the projects viable.

Now, the acceptance from the Government of Kerala for exempting royalty on earth/boulders and reimbursement of state GST components in the project of Ernakulam Bypass, Kollam-Shenkottai Greenfield Corridor and Thiruvananthapuram Outer Ring Road has been received in July/August, 2024.
