PRADHAN MANTRI SHRAM YOGI MAAN-DHAN SCHEME

191. SHRI KARTIKEYA SHARMA:

Will the Minister of Labour and Employment be pleased to state:

- (a) the current outreach and coverage of the Pradhan Mantri Shram Yogi Maan-dhan (PM- SYM) scheme, with the enrolment details thereof, State-wise;**
- (b) the measures undertaken to address the challenges faced by workers in maintaining consistent contributions to the PM-SYM scheme, particularly during periods of income uncertainty or job loss, the details thereof; and**
- (c) the initiatives taken to increase enrolment figures under the scheme, with the State-wisedetails thereof?**

STATEMENT REFERRED TO IN REPLY TO PART (a) TO (c) OF RAJYA SABHA STARRED QUESTION NO. 191 FOR 12.12.2024 RAISED BY SHRI KARTIKEYA SHARMA REGARDING PRADHAN MANTRI SHRAM YOGI MAAN-DHAN SCHEME.

(a) to (c): The Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) scheme launched in 2019, is a voluntary and contributory pension scheme, to provide old age protection to workers of unorganised sector. A monthly assured pension of Rs. 3000/- per month is provided on attaining the age of 60 years. Enrollment age is 18 to 40 years. Under the scheme contribution is equally shared by the beneficiaries and the Central Government.

As on 09.12.2024, 50,84,059 beneficiaries are enrolled under the scheme. The state-wise details are annexed.

To address challenges faced by workers in maintaining consistent contribution to PM-SYM scheme, beneficiaries of PM-SYM are allowed to resume default/ dormant/ suspended account upto 3 years from the date of default on payment of unpaid installment along with interest and penalty.

Steps to increase enrollment in PM-SYM include review meetings with States/ UTs and State heads of Common Service Centres (CSCs), two-way integration of PM-SYM and eShram, SMS campaign, Donate-a-Pension module to encourage employer to pay contribution to workers; facility to view account statement free of charge.
