- (a) IREDA has total loan outstanding asset value of Rs.64,564.36 Crore and net Non-Performing Assets (NPA) of Rs.665.58 Crore as on 30.09.2024. The details of profit before tax (PBT) and profit after tax (PAT) during the last two financial years and current financial year (quarter-wise) is placed at **Annexure I.**
- (b) Loans are provided to the project developers including startups and MSMEs based on technocommercial viability of the projects subject to meeting the eligibility criteria of IREDA's Financing Norms.
- (c) IREDA has disbursed Rs.5,028 Crore cumulatively in the state of Madhya Pradesh, out of which Rs.3,194 Crore is outstanding as on 27.11.2024.
- (d) State/ UT wise CSR spent by IREDA during the last three financial year is placed **at Annexure II.**
