CATTLE REARING

1024. DR. V. SIVADASAN:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING be pleased to state :

- (a) number of cows and buffaloes in the country, State-wise, year-wise details for the last five years;
- (b) whether any subsidy is provided to the dairy farmers who are rearing cows and buffaloes, year-wise details for the last five years; and
- (c) whether any fund have been allocated by Government for addressing the problem of stray cattle in the country, year-wise details for the last five years?

ANSWER

THE MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI RAJIV RANJAN SINGHALIAS LALAN SINGH)

- (a) The details of number of cows and buffaloes in the country, State-wise, year-wise for the last five years is given at **Annexure –I**.
- (b) No subsidy is provided to the dairy farmers who are rearing cows and buffaloes. However, Department is implementing Accelerated Breed Improvement programme using Sex sorted semen technology under Rashtriya Gokul Mission. Under the component, Sex sorted semen production for indigenous breeds of cattle along with other bovine breeds has been initiated in the country and it is important for production of female calves with 90% accuracy and incentive of Rs. 750 or upto 50% of the cost of sorted semen on assured pregnancy is made available to farmers.
- (c) No specific funds have been allocated by the Government for addressing the problem of stary cattle in the country. However, as replied in part (b) above, the component namely "Sex sorted semen technology" plays a crucial role in enhancing farmers income and also limiting stray cattle population.
 - Under Article 246(3) of the Constitution of India, matters related to the preservation, protection, and improvement of livestock, prevention of animal diseases, and veterinary

training fall under the State List, granting states exclusive legislative powers. Additionally, Article 243(W) entrusts local bodies with responsibilities such as managing cattle pounds and pinjrapoles. States may empower Panchayats to establish and manage Cattle Pounds (Kanji Houses) or Gaushala Shelters as community assets to house stray cattle. Many states have already established Gaushalas and shelter houses to feed and care for such animals.

Animal Welfare Board of India provides assistance to the Animal welfare organizations recognized by AWBI. The status of funds released during last five years is given at **Annexure -II.**

The management of stray animals is largely undertaken by Gaushalas, Panjra Poles, Kanji Houses, and NGOs. Funding for their maintenance is sourced from these organizations, and some states supplement this with budgetary assistance or special taxes.
