Will the Minister of HOME AFFAIRS be pleased to state:

(a) the number of cases registered, persons arrested, and persons convicted under the UAPA during last five years, State-wise and year-wise along with the year-wise rate of conviction;

(b) whether any step has been taken to provide support or compensation to individuals acquitted after being detained under UAPA provisions, details thereof; and

(c) number of cases booked under UAPA against journalists over the past five years?

(a) The National Crime Records Bureau (NCRB) compiles the data on crime and publishes the same in its annual publication 'Crime in India'. The latest published report is of the year 2022. As per the report, State-wise and year-wise details of cases registered, persons arrested, persons convicted and rate of conviction under UAPA for the years 2018, 2019, 2020, 2021 and 2022, are at Annexure.

(b) There is no provision made for providing support or compensation to individuals acquitted under UAPA. Adequate constitutional, institutional and statutory safeguards including inbuilt safeguards in the UAPA itself exist to prevent misuse of the law.

(c) The data regarding the cases booked under UAPA against journalists is not maintained by National Crime Records Bureau (NCRB).
