**E-GRAMSWARAJ AT PANCHAYATI LEVEL**

Will the Minister of Panchayati Raj be pleased to state:

(a) whether Government has launched any application to support Gram Panchayats to encourage spatial planning at Gram Panchayat level using geo-spatial technology in Himachal Pradesh;

(b) if so, the details thereof;

(c) Service Ready Gram Panchayats along with adoption of e-GramSwaraj at Panchayati level during 15th Finance Commission for year 2024-25, State-wise details thereof; and

d) whether Government has taken any measure to implement more projects under Digital India Programme, with the aim to make Panchayats, more transparent, accountable, and effective as local self-government across the country?

**ANSWER**

(a) & (b) In order to encourage the Spatial Planning by the Gram Panchayat, Ministry of Panchayati Raj had launched the Geographic Information System (GIS) application “Gram Manchitra” (<https://grammanchitra.gov.in>). This application facilitates and supports Gram Panchayats to perform planning at Gram Panchayat level using geo-spatial technology. It provides a single/ unified Geo Spatial platform to better visualize the various developmental works to be taken up across the different sectors and provide a decision support system for Gram Panchayat Development Plan (GPDP). The application supports Gram Panchayats across India, including Himachal Pradesh, in planning effectively using geo-spatial technology.

(c) & (d) Under Digital India Programme, Ministry of Panchayati Raj is implementing e-Panchayat Mission Mode Project (MMP), in all the States/ UTs of the country. The aim is to revamp the functioning of Panchayats and to make them more transparent, accountable and effective. Ministry has launched eGramSwaraj, an accounting application to simplify Panchayat work like planning, accounting and budgeting. Ministry has also integrated eGramSwaraj with Public Financial Management System (PFMS) for Gram Panchayats (GPs)

to make real time payments to vendors/service providers. The progress made by States, under eGramSwaraj for the year 2024-25 is given at **Annexure-I**.

Further, an application of ‘AuditOnline’ has been developed for online audits of Panchayat accounts and their financial management. AuditOnline for transparent auditing of Central Finance Commission funds utilization for strengthen financial management of Panchayats launched in April 2020. Beside this, applications developed by the Ministry like ‘Meri Panchayat App’ has endeavoured to bring transparency in Panchayat Governance by making information on planning, activities and progress of works in Panchayat easily accessible to public on online platform. Similarly, ‘Panchayat Nirnay’ is an online application aims at bringing transparency and better management in conduct of Gram Sabhas by Panchayats.

For providing high bandwidth capacity, expansion of mobile services and broadband connectivity in rural and remote areas, BharatNet project is being implemented by Department of Telecommunications in a phased manner to create network to connect all Gram Panchayats (approx. 2, 55,000) in the country. State/UT-wise Service Ready GPs as available at the BharatNet UNMS Dashboard is at Annexure-II. There may be more than one service-ready points in a Gram Panchayats.
