**STATUS OF THE PMKVY**

1076. SHRI P. P. SUNEER:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the present status of the Pradhan Mantra Kaushal Vikas Yojana (PMKVY) including the total number of yearly candidates registered, trained and given certificates under the scheme during last five years, State-wise details thereof;
- (b) number of candidates who received placement assistance by Training Partners, year-wise, State-wise;
- (c) number of candidates who received employment after completing training under the scheme, sector-wise, year-wise, state-wise; and
- (d) the total yearly expenditure incurred under the scheme, provide both Centrally-Sponsored Centrally-Managed and Centrally-Sponsored State-Managed data?

**ANSWER**

THE MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(a) Ministry of Skill Development and Entrepreneurship (MSDE) is implementing its flagship scheme Pradhan Mantri Kaushal Vikas Yojana (PMKVY), since 2015, for imparting skill development training through Short-Term Training (STT) and up-skilling and re-skilling through Recognition of Prior Learning (RPL) to youth across the country. Under PMKVY, placement opportunities have been facilitated to STT certified candidates and RPL involves the process of certification of already existing skills.

Under the PMKVY scheme, state-wise and financial year wise details of candidates enrolled, trained/oriented, certified during last five financial years from FY 2019-20 to FY 2023-24 are available as Annexure on Ministry's website at <https://msde.gov.in/en/useful-links/parl-ques/lok-sabha>.

(b & c) Under the PMKVY scheme, placements were tracked in the Short-Term Training (STT) component in the first three versions of the Scheme which is PMKVY 1.0, PMKVY 2.0 and PMKVY 3.0 implemented from FY 2015-16 to FY 2021-22. Under PMKVY 4.0, the

focus is on empowering the trained candidates to choose their varied career path and they are suitably oriented for the same. Further various IT tools like skill India Digital Hub (SIDH) also gives this opportunity.

(d) The PMKVY (except PMKVY 1.0 (2015-16) and PMKVY 4.0(2022-26)) had two components, namely Centrally Sponsored Centrally Managed (CSCM) component being implemented through National Skill Development Corporation (NSDC) and Centrally Sponsored State Managed (CSSM) component being implemented through State Skill Development Mission of the States/UTs.

Under the PMKVY Scheme, details of total yearly expenditure incurred for both CSCM and CSSM component is as under:
