#### STATES WITH THE TARGET PVTG POPULATION

#### 1095 SHRI V. VIJAYASAI REDDY:

Will the Minister of *Tribal Affairs* be pleased to state:

- (a) is it a fact that with nearly 5 lakh, Andhra Pradesh is one of the top three States with Particularly Vulnerable Tribal Groups (PVTG) population in the country;
- (b) if so, details thereof, district-wise;
- (c) the extent to which PM JANMAN helping the above PVTG households and habitations with safe housing, clean drinking water, improved access to education, health and nutrition, road connectivity, telecommunications, electrification, etc.; and
- (d) the number of PVTG covered/provided with the above facilities in Andhra Pradesh so far out of 5 lakhs?

#### ANSWER

## MINISTER OF STATE FOR TRIBAL AFFAIRS (SHRI DURGADAS UIKEY)

- (a) & (b): PM JANMAN mission is being implemented by the Ministry of Tribal Affairs through the State Governments/ UT Administration/departments including Andhra Pradesh. States have undertaken habitation level data collection exercise through PM Gati Shakti mobile application to estimate PVTG population figures and infrastructure gaps in order to cover PVTG population residing in villages & habitations. Based on the data captured (as on 21.11.2024), Andhra Pradesh with PVTG population of 492552 is one of the top three States with PVTG population in the country. The PVTG population, District-wise, in Andhra Pradesh (as on 21.11.2024) are tabulated at Annexure-I.
- (c) & (d): Pradhan Mantri Janjati Adivasi Nyaya Maha AbhiyaN (PM JANMAN) is aimed at socio-economic development of 75 PVTG communities residing in 18 states and one UT. Under the mission, basic facilities such as safe housing, clean drinking water and improved access to education, health and nutrition, road and telecom connectivity, electrification of unelectrified households and sustainable livelihood opportunities are provided. The details of benefits given under PM JANMAN (as on 21.11.2024) in Andhra Pradesh since its inception is given in **Annexure-II**.
