## Projects sanctioned under various schemes for Assam

## 1147 Shri Ajit Kumar Bhuyan:

Will the Minister of DEVELOPMENT OF NORTH EASTERN REGION be pleased to state:

- (a) whether it is a fact that every year under various schemes, many projects have been sanctioned by the Ministry for Assam;
- (b) if so, the details thereof;
- (c) the number of projects which have been sanctioned in current financial year and amount of funds that have been allocated to Assam in various projects, project-wise details;
- (d) the number of projects completed in the sanctioned projects for the current financial year and the status of remaining projects;
- (e) whether there is any projects proposal submitted by the State Government; and
- (f) the budgetary allocation of the Ministry for Assam?

#### **ANSWER**

# The Minister of State of the Ministry of Development of North Eastern Region [Dr. Sukanta Majumdar]

- (a) to (d):Yes, Sir. The Ministry of Development of North Eastern Region (MDoNER) sanctions projects every year for all the North Eastern States including Assam. During the last 10 years from 2014-15 to 2023-24 and the current financial year 2024-25, a total of 231 projects costing Rs 5812.65 crore have been sanctioned for the State of Assam under various schemes of MDoNER. The details of projects sanctioned/completed for the State of Assam during the current financial year 2024-25 are annexed.
- (e) A total of 29 project proposals costing Rs.1387.04 crore have been received from the Government of Assam under various schemes of MDoNER for sanction.
- (f) The total budgetary outlay of Assam under various schemes of MDoNER during the 15<sup>th</sup> Finance Commission period ending on 31.03.2026 is Rs.3225.78 crore.
