Will the Minister of Labour and Employment be pleased to state:

- (a) the initiatives and achievements under the e-Shram portal;**
- (b) the number of registrations till date;**
- (c) whether Government is planning to increase the labour employment in the country; and**
- (d) if so, the details thereof and if not, the reasons therefor?**

ANSWER

**MINISTER OF STATE FOR LABOUR AND EMPLOYMENT

(a) to (d): The Ministry of Labour and Employment launched eShram portal (eshram.gov.in) on 26th August 2021 for creation of a comprehensive National Database of Unorganised Workers (NDUW) verified and seeded with Aadhaar. eShram portal is meant to register and support the unorganised workers by providing them a Universal Account Number (UAN). As on 1st December 2024, over 30.43 crore unorganised workers have registered on eShram portal.

The details of initiatives and achievements under the eShram Portal are as under:

- i. The registration in the portal is Aadhaar verified and Aadhaar seeded. Any unorganised worker can register on the portal on a self-declaration basis.**
- ii. Provision has been added in eShram to capture family details of migrant workers.**
- iii. Provision has been added in eShram to share construction workers' data with States/ Union Territories to facilitate their registration in respective Building and other Construction Workers (BoCW) Boards.**

- iv. **eShram has been integrated with National Career Service (NCS) portal. An unorganised worker can register on NCS using the Universal Account Number (UAN) and search for suitable job opportunities. An option/ link has also been provided to registrant on eShram portal to seamlessly register on NCS.**
- v. **eShram is also integrated with Pradhan Mantri Shram Yogi Maandhan (PM-SYM). PM-SYM is a pension scheme for unorganised workers who are aged between 18-40 years. Using UAN (eShram), any unorganised worker can easily register on Maandhan portal.**
- vi. **To provide skill enhancement and apprenticeship opportunities to unorganised worker, eShram has been integrated with Skill India Digital portal of Ministry of Skill Development and Entrepreneurship.**
- vii. **eShram is also integrated with myScheme portal. myScheme is a National Platform that aims to offer one-stop search and discovery of the Government schemes. It provides an innovative, technology-based solution to discover scheme information based upon the eligibility of the citizen. The platform helps the citizen to find the right Government schemes for them. It also guides on how to apply for different Government schemes. Through this integration, all the eShram registrants can check the schemes for which they are eligible.**
- viii. **Ministry of Labour and Employment launched the eShram–“One-Stop-Solution” on 21st October 2024. eShram–“One-Stop-Solution” entails integration of different Social Security/ Welfare schemes at single portal i.e. eShram. This enables unorganised workers registered on eShram to access social security schemes and see benefits availed by them so far, through eShram.**

So far, 12 schemes of different Central Ministries / Departments have already been integrated/ mapped with the eShram including Pradhan Mantri Suraksha Bima Yojana (PMSBY), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana, Prime Minister Street Vendors AtmaNirbhar Nidhi (PM-SVANidhi), PM Awas Yojana- Urban (PMAY-U), PM Awas Yojana- Gramin (PMAY-G), Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA).

Employment generation coupled with improving employability is a priority of Government and is a multi stakeholder initiative. The various Ministries/ Departments of Government of India like Ministry of Micro, Small and Medium Enterprises, Ministry of Rural Development, Ministry of Housing and Urban Affairs, Ministry of Finance, Ministry of Textile, etc. are implementing different employment generation schemes/ programmes.
